

FACT SHEET Earthworks Industries Inc., through its 100% owned subsidiary Cortina Integrated Waste Management Inc. (CIWM) has successfully negotiated a lease with the Cortina Band of Wintun Indians to design, construct and operate an integrated waste handling facility on 443 acres of the Cortina Rancheria in Colusa County, California. The Class III landfill located approximately 85 miles north-east of San Francisco, California will have an approximate disposal capacity of 16 million cubic yards of waste. The initial lease is 25 years, and renewable in 25 years.

PURPOSE AND NEED

The project will provide long-term revenue to the Cortina Band along with socioeconomic development and employment opportunities for Band members. Colusa County will benefit through:

- *economic boom for region*
- *employment benefit to local county*
- *long term waste needs*

Comprehensive solid waste management regulations developed that comply with or exceed the requirements of the federal and California solid waste regulations.

THE PROPOSED PROJECT

The lease area includes 443 acres of the 640 acre Cortina Rancheria in Colusa County and includes:

- *Class III landfill (municipal waste)*
- *Material Recovery Facility*
- *Compositing Facility*
